

OFFICERS' REPORTS

President's:

- Introduced new Board member, Neil Cavaleri
- Bike riding and walking allowed on golf cart paths when course is closed after 12/24
- Tennis court maintenance will begin at 10am daily until 12/24 and then will be discontinued until spring
- Indoor pool temperature has been raised to between 84-85 degrees

Treasurer's:

While the bar is an amenity, we also realize that it has to run like a business.
 A review was in order and we targeted three areas: pricing, expenses and salary cost. It has been decided to adjust the retail prices of the bar to be in sync with the cost prices. Most prices will remain the same, some will go down and others will go up. We intend to monitor these changes monthly.
