



## Swimming Pool Rules and Regulations

The following Rules and Regulations supersede any prior documents, policies or procedures regarding swimming pool rules, including Administrative resolution 2009-04 adopted June 11, 2009 and swimming pool & whirlpool Rules and Regulations noted in Title II Chap 2, article 4 "Swimming Pool" in the by-laws.

### SWIMMING POOL AND WHIRLPOOL RULES AND REGULATIONS

**The Following rules apply to both the Indoor and Outdoor pools:**

- 1) No person (resident or non-resident) is permitted to enter any pool area unless a lifeguard is on duty and in the pool enclosure.
- 2) The lifeguard is responsible for the supervision of the pool and surrounding areas. Please do not divert the lifeguards' attention unnecessarily. The enforcement of the rules and regulations is the responsibility of the lifeguard(s) and all users of the pool must respect their authority. We urge that there be no confrontation with the staff. Any disagreement with the enforcement of these rules by the lifeguard should be directed to the Management.
- 3) Chairs are available on a first come first served basis; reservation of chairs is not permitted. It is mandatory that a towel be used to cover the chair before use.
- 4) Any persons showing signs of skin disease, sore or inflamed eyes, nasal discharge, or any communicable disease shall be refused admission to the pool area. Persons with excessive sunburn, open blisters, cuts or bandages may be refused admission to the pool area.
- 5) Glass containers, alcoholic beverages, food, and smoking are not permitted in the pool area.
- 6) Persons suspected of being under the influence of drugs or alcohol will be refused admission to the pool area.
- 7) No pets other than service animals are permitted in the pool areas.
- 8) There shall be no running, ball playing, diving or jumping, etc. in the pool areas. Any conduct affecting the enjoyment of others is prohibited and any persons involved are subject to the suspension of pool privileges.
- 9) Any persons using the pool must shower before entering the pool in accordance with New Jersey State Health Requirements.
- 10) The whirlpool should not be used by anyone with high blood pressure or a history of circulatory or similar illness and cannot be used by anyone under the age of 19 years old.
- 11) Radios, cassette players, and CD players etc. may only be used with headphones; exception is the water aerobics classes.
- 12) A sign indicating the maximum occupancy of the pool area will be posted and will be strictly enforced.
- 13) Valid IDs must be produced for each Homeowner and guest using the facilities. Any persons without Valid ID will be refused admission to the pool area. Upon entering the pool area all homeowners and their guests must register using the pool sign in log provided by the lifeguard. There are only four (4) guests permitted per household. There will be absolutely no exceptions to this rule. Guest hours are set annually by the Board of Directors. Please check the website or current postings at the Concierge desk. No bare feet anywhere in the clubhouse other than the immediate area of the swimming pool.
- 14) Children under the age of three (3) years old are not permitted in the indoor or outdoor pool area. Children who are not potty trained cannot enter the pool area. An adult must be in the water at all times with non-swimming children.
- 15) Flotation devices including safety jackets containing the **US Coast Guard Seal** of approval are permitted on small children. Kick boards, rafts, tubes, toys, etc. of any kind are not permitted in the pool or surrounding areas at any time.



- 16) Adult supervision is mandatory at all times for children under the age of 12 years old. The lifeguards will not be used as babysitters. The host homeowner must accompany and will be responsible for their guest at all times.
- 17) Residents are responsible to make sure that the areas they use are kept clean and neat. All areas used should be returned to their original condition.
- 18) Strollers are not permitted inside the enclosed pool areas.
- 19) No diapers of any kind are permitted in the indoor or outdoor pool.
- 20) Chairs, lounges and tables may not be reserved or saved. Personal property such as towels, coolers, beach bags and clothing left on chairs, lounges or tables that remain unoccupied for 30 minutes will be removed to the lost and found area.
