

Oceanaire Women's Golf Association

By-Laws – Approved September 29, 2016

Article I

The Name of this Association shall be Oceanaire Women's Golf Association (OWGA).

Article II

The purpose of this Association is to provide a program of organized golf for its members in coordination with the professional golf staff.

Article III

All women golf members of the Greenbriar Oceanaire Golf Club with a USGA handicap will automatically be members of the OWGA and will be able to play on Ladies' day based on guidelines set by the Director of Golf. If women do not have an established handicap, they will be social members of the OWGA only until a handicap is established.

Article IV

Acceptance of membership in the Association shall require each member to abide by the conditions of the By-Laws.

Article V

Nominating Committee: It is the function of the Nominating Committee to choose a slate of candidates for the Chairperson and two (2) Vice-Chairperson positions. The Committee will consist of the current Chairperson and other volunteers from the general membership. The Chairperson will set a meeting date for the Nominating Committee prior to the final general meeting of the season and chair said meeting.

Article VI

Tournament Eligibility: A USGA handicap is required for all 9 and 18 hole events.

Article VII

The OWGA Committee will meet on a monthly basis, or as deemed necessary, and will be responsible for establishing a schedule of social events and for the appointment of the Nominating Committee, and for other functions as deemed necessary.

The OWGA Committee, whose term of office will be one (1) year with an effective date of November 1, will consist of:

Chairperson: The Chairperson will be responsible to see that all functions of the Committee are carried out and will appoint other committee members as necessary.

Vice-Chairpersons (2 positions): Under the guidance of the Chairperson, the Vice-Chairpersons will be responsible for secretary and treasurer functions as deemed necessary, and will assist the Chairperson.

Article VIII

No dues will be collected. Money for social events will be on a pay as you go basis.

Article IX

Amendments to the By-Laws will be written by the By-Laws Committee. This Committee will consist of a the Chairperson, 2 Vice-Chairpersons, and representatives from the general membership. **The** By-Laws Committee will receive recommendations for changes from any Association member.

Recommendations will be formulated by the By-Laws Committee and presented to the OWGA Committee for approval. If approved, all changes will be posted for review by the membership one month prior to a monthly meeting of the membership of OWGA, at which time the amendments will be voted on.

Article X

The monthly meeting of the membership of OWGA will be held on the 2nd Thursday of every month beginning in April and ending in the Fall . At the annual fall meeting/closing day luncheon, reports will be presented and new Chairpersons will be announced.

Article XI

To hold harmless and indemnify the Oceanaire Women's Golf Association, its officers and participants, the Greenbriar Oceanaire Board of Directors, Greenbriar Oceanaire Homeowners Association, the Township of Ocean, Prime Management, Lennar, and all officials from all claims, damages, losses, and injuries that may be incurred during all Oceanaire Women's Golf Association events, and any other activities related to the Oceanaire Women's Golf Association.
